An overwhelming percentage of corporate costs relate to the Monger Gold IPO which the company has now been reimbursed for. Further a significant percentage of the exploration costs were related to invoices incurred in the previous quarter. As such the company does not anticipate a similar level of outgoing cash flows moving forward.

The entity is engaged in securing funding for the purchase of the Tarmoola station, which it anticipates would be cash flow positive, and generate sufficient income to cover repayments and corporate costs.
